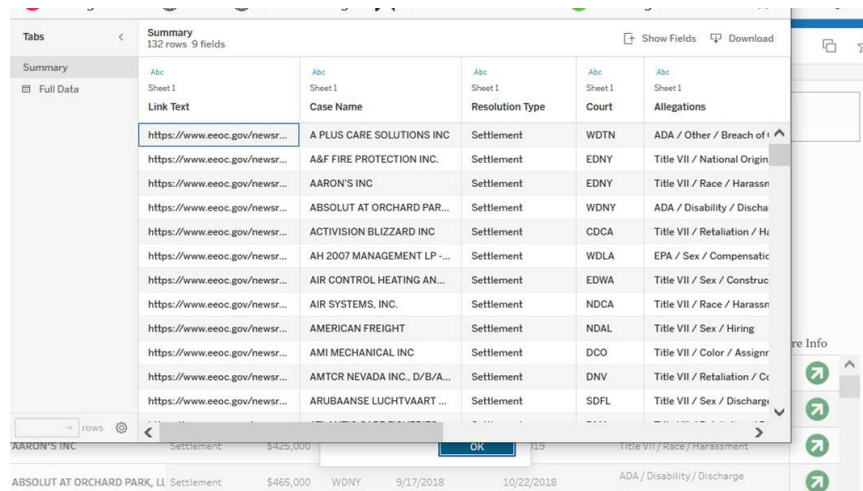

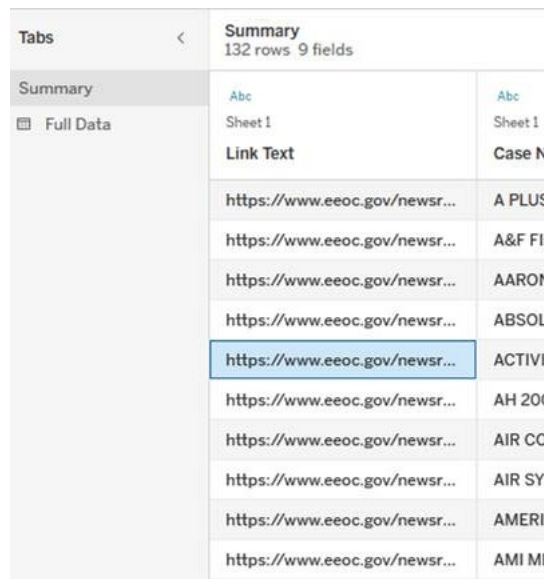

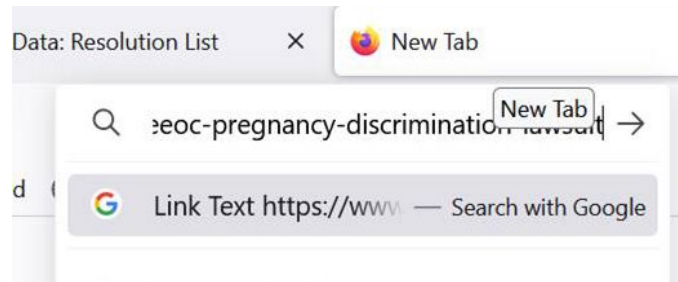
On your keyboard press the Shift+Enter simultaneously and a pop up box opens containing the links to the case press releases.



Use the arrow down key to highlight the press release you are interested in, and on your keyboard press Ctrl+C to copy the link to the press release.



Once the link is copied then type Ctrl+T to open a new tab in your web browser



On your keyboard type Ctrl+V to paste the press release link in the new tab.

Once the link is pasted in the web browser on your keyboard use the Fn+Left Arrow keys to bring the cursor to the beginning of the URL.

Delete the beginning of the URL “Line Text” and then press “Enter” on your keyboard to go to the press release link.
